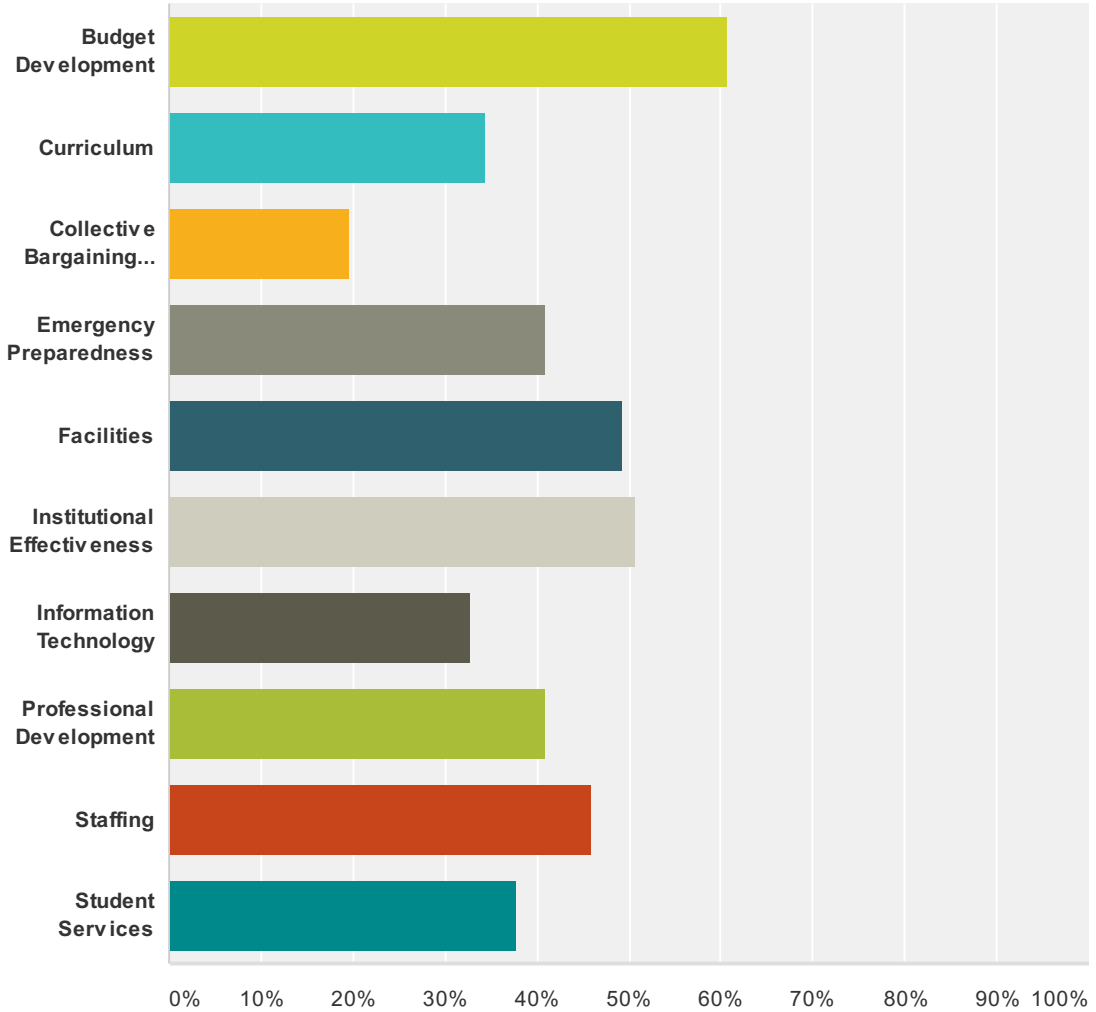

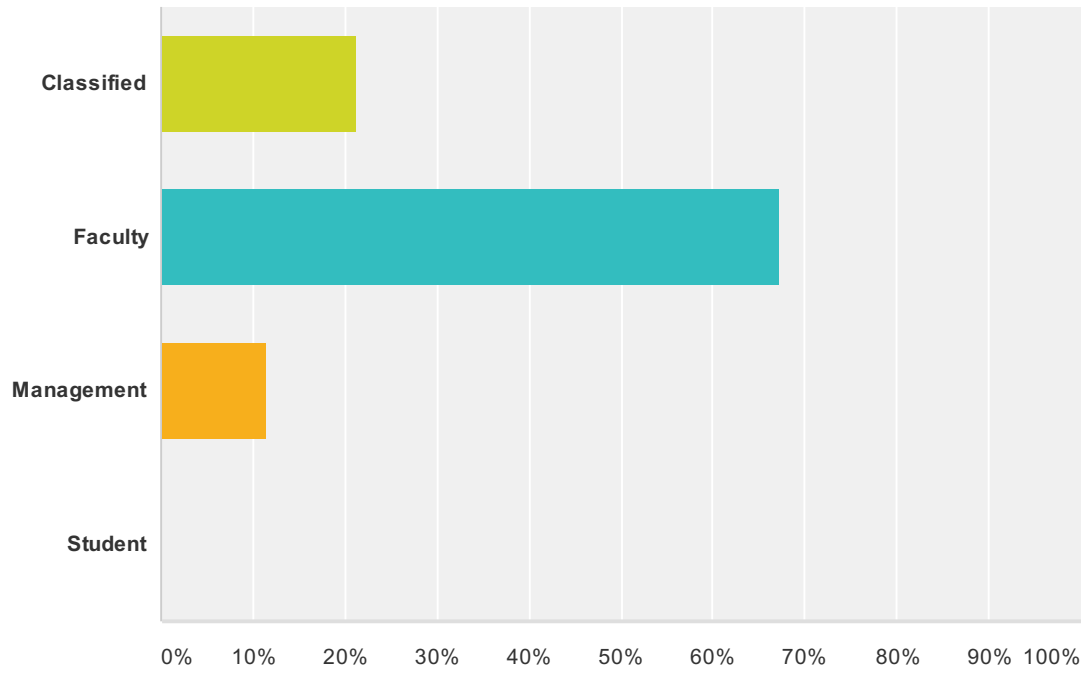

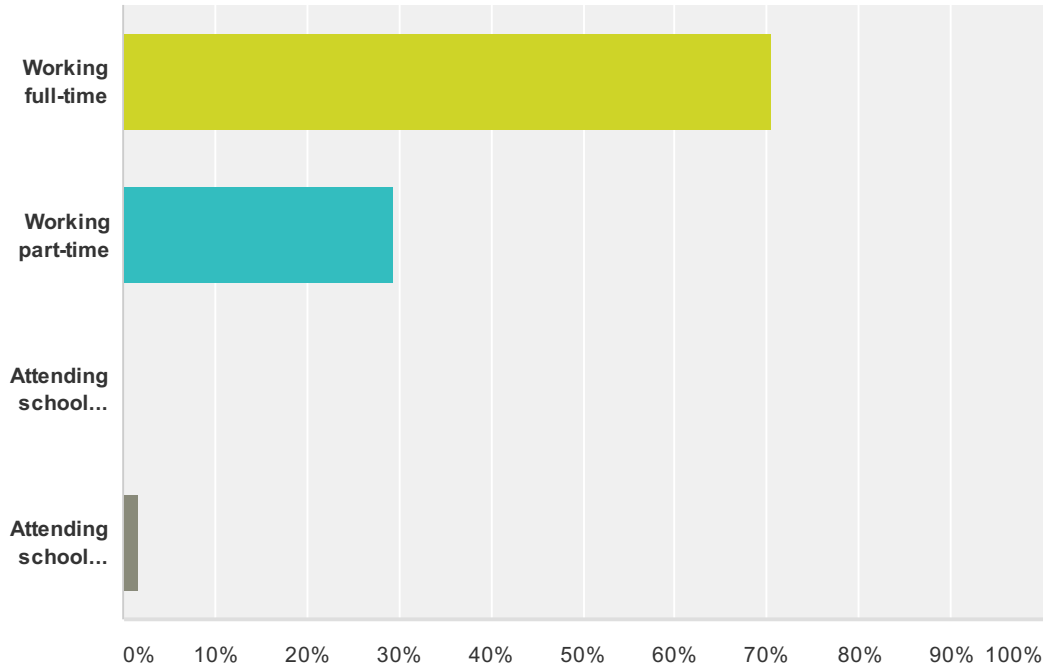

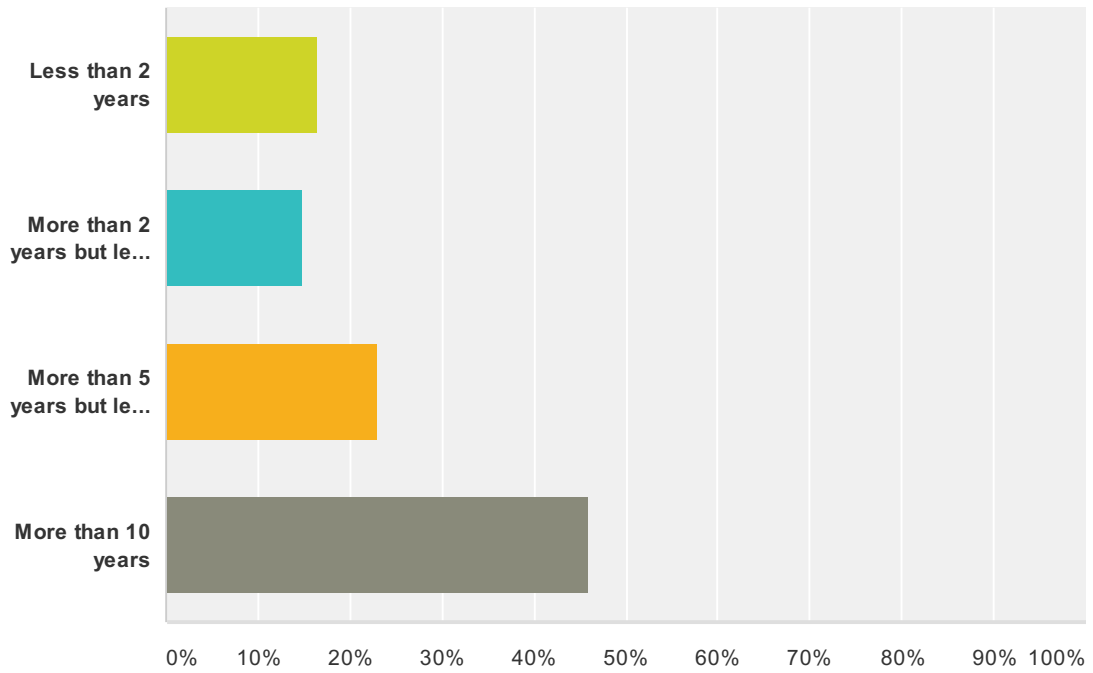

Q17 How long have you worked or attended school at Cerro Coso Community College?

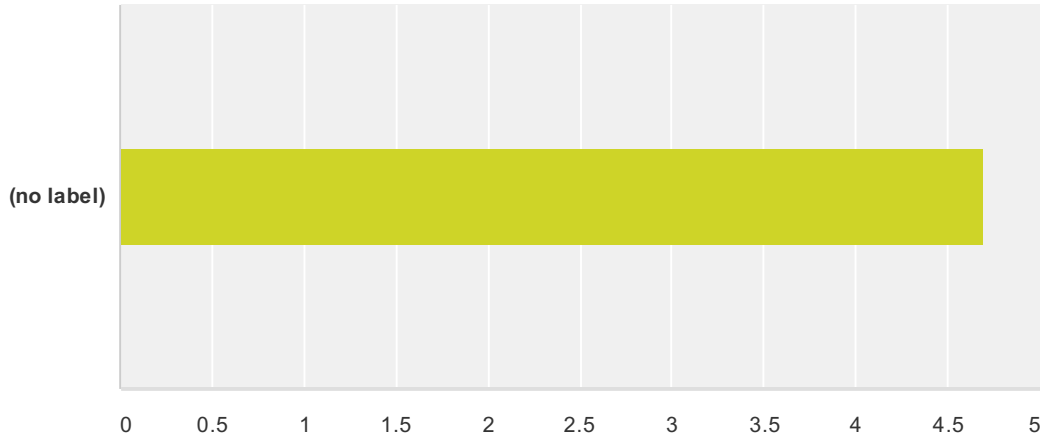

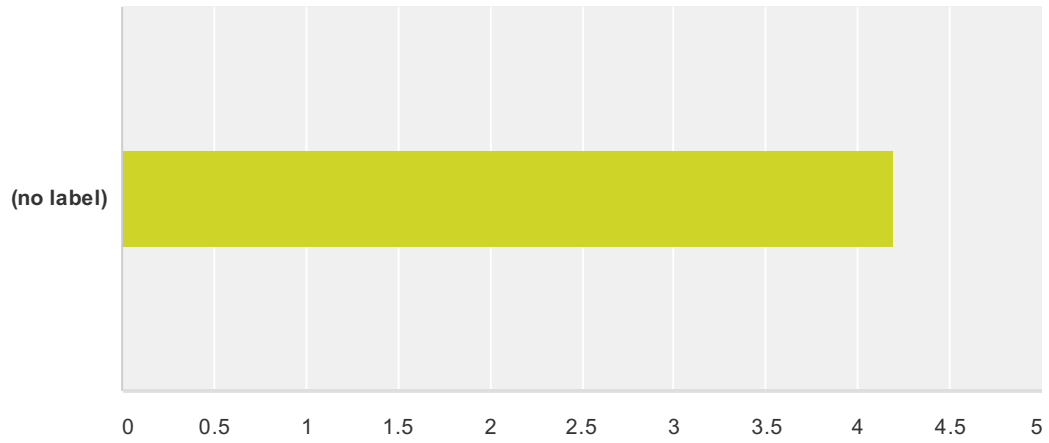

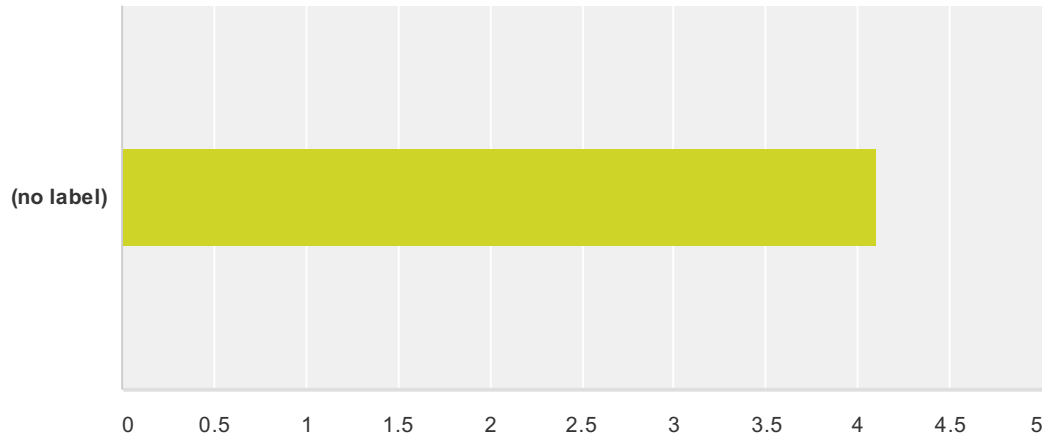

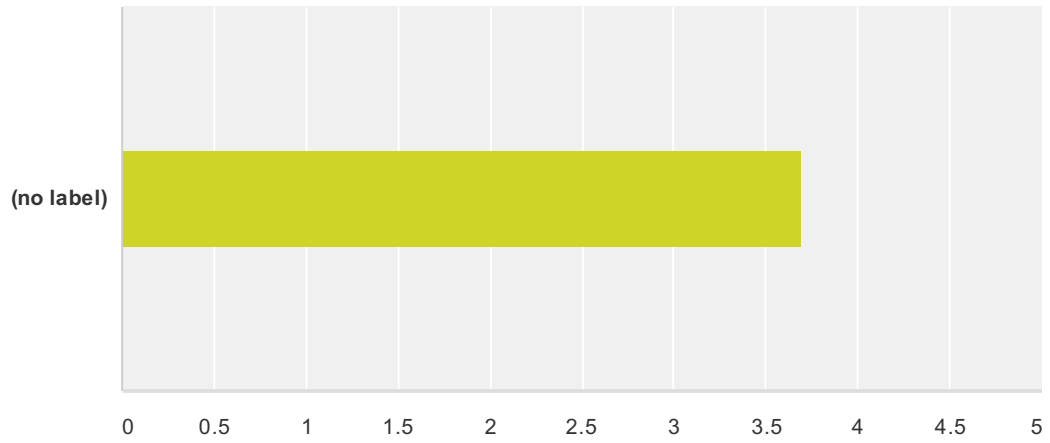

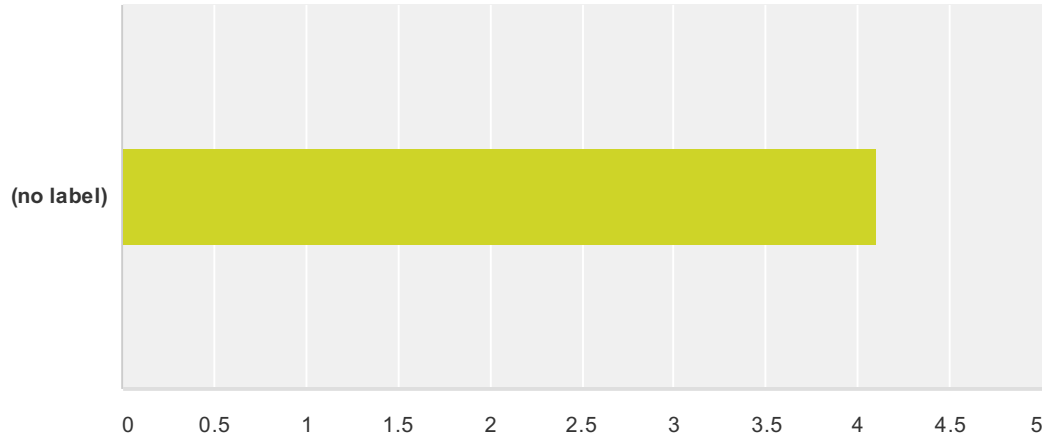

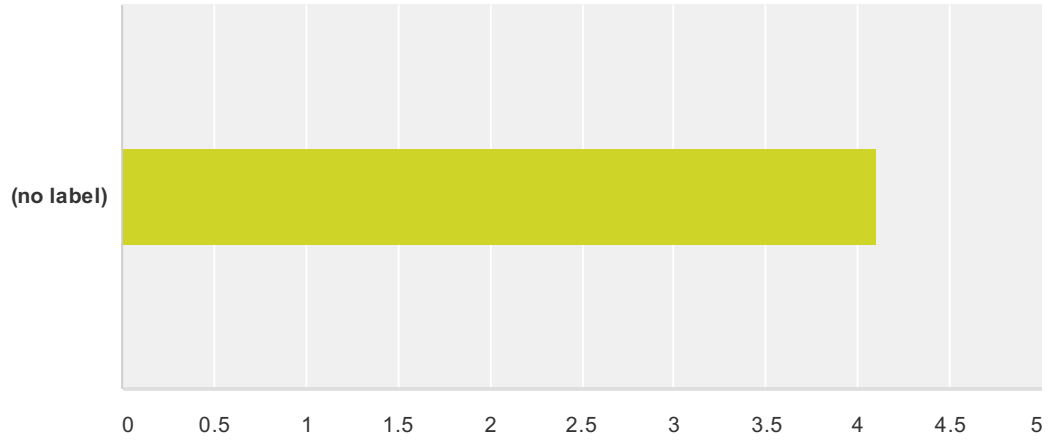
