- Conduct Executive retreat and follow up activities to measure and address internal relational issues with District Management in 2017.
- Conduct 2019 survey indicating measured improvement in relational issues amongst District Management
- Establish new District management performance review system incorporating identifiable and measurable goals and objectives by 2018.
