In the event that you are readmitted, the following requirements must be fulfilled:

- 1 According to Procedure 4C5 of the Board Policy Manual you are limited to enrollment in no more than seven units.
- As a result of your current disqualification status an automatic unit limitation of 7 units will be placed on your registration. Your counselor/educational advisor must approve your schedule of classes before you can register. If you achieve a 2.0 GPA and/or improve your completion of units to over 50% when grades are finalized, you may be eligible to enroll in more units.
- 3 You are required to enroll in a class organized to meet the needs of students who have serious academic problems. This will be a condition of re-enrollment. You should discuss with your counselor or Educational Advisor the courses available to meet this requirement.
- 4 You are required to schedule regular appointments with your counselor to discuss academic progress, plan for subsequent semesters, and get approval for any change in your class schedule.
- 5 Your registration for a subsequent semester is blocked until grades for the current term are submitted, and you have counselor approval for re-enrolling.

If you are readmitted under "disqualified status," you are required to achieve a 2.0 grade point average (GPA) for the current term in order to be registered for a subsequent semester, or in the case of Progress Disqualification you are required to complete more than 50% of the units you have attempted. Failure to achieve these standards for either Academic or Progress Disqualified Status will mean that you will only be considered for readmission after again going through the Petition for Readmission procedure and will be denied admittance for one or more semesters.
