# IX. EDUCATIONAL SERVICES – CONSENT

The Educational Services items listed below are recommended for ratification or approval by State Law, State Regulations, or approval in accordance with the Board Policy Manual of the Kern Community College District. Only one motion is required to provide action on all.

- 1. Training Center Agreement between the Kern Community College District, on behalf of Bakersfield College, and the American Heart Association as recommended in the Educational Services Report. Bakersfield College will continue to offer American Heart Association Basic Life Support courses and to operate as an American Heart Association Training Center. The term is June 1, 2012 through May 30, 2014 and there is no cost to the District.
- 2. Renewal Agreement between the Kern Community College District, on behalf of Bakersfield College, and Hall Ambulance Service, Inc. as recommended in the Educational Services Report. Bakersfield College will partner with Hall Ambulance to provide an EMT-1 academy training for their potential employees. The term is July 1, 2012 through June 30, 2014 and the net income to be deposited into contract education fund.

- 3. Amendment to Statement of Work between the Kern Community College District, on behalf of Cerro Coso Community College, and SRI International as recommended in the Educational Services Report. SRI International will meet with Cerro Coso Community College personnel in order to conduct targeted research on the development of community college and industry partnerships for the National Science Foundation Grant. The term is August 1, 2011 through July 31, 2012 and the increased income payable to the District is \$840 for a total amount of \$3,300 to be deposited into the general fund.
- 4. Agreement between the Kern Community College District, on behalf of Cerro Coso Community College, and Bishop Paiute Tribe to deliver a contract education course, Federal OSHA-10 as recommended in the Educational Services Report. The term is August 9-10, 2012 and the net income payable to the District is \$700 to be deposited into contract education fund.
- 5. Grant between the Kern Community College District and Pacific Gas and Electric Company as recommended in the Educational Services Report. The grant will support Cerro Coso Community College's Extended Orientation process and is part of the Student Success Plan.
- 6. Amendment to the Memorandum of Understanding between the Kern Community College District, on behalf of Porterville College, and National University as recommended in the Educational Services Report. National University will offer a Bachelor's Degree in Business on the Porterville College campus. The term is August 1, 2012 through August 31, 2015 and there is no cost to the District.
- 7. Community Education classes as recommended in the Educational Services Report. The classes include: Recreational Piano and Repairing and Maintaining Home Irrigation Systems. Revenues will be deposited into a community education fund.

The Clean Energy Center will provide WorkKeys testing, workforce education and training on a per participant basis for participants referred by and participating in the California Veterans Assistance Foundation. The term is July 1, 2012 through June 30, 2013 and the net income payable to the District is \$11,142 to be deposited into contract education fund.
