Cerro Coso Vocational Nursing AS Degree Program

VOCATIONAL NURSING ASSOCIATE OF SCIENCE DEGREE: This course of study is an intensive program totaling 1,662 hours approved by the Board of Vocational Nursing and Psychiatric Technicians. The hours include anatomy and physiology, psychology, certified nurse aide (CNA), nursing theory, and supervised clinical nursing experiences. Concepts integrated throughout the first semester of the program include: fundamentals of nursing, geriatrics, nutrition, and pharmacology. Nursing care of clients with various adult medical-surgical conditions is integrated throughout three semesters of the program. Course content also includes concepts of growth and development, normal obstetrics and pediatrics. After successful completion of the program, the student is eligible to take the licensure examination provided by the National Council of State Board of Nursing (NCLEX-PN).

All prerequisites must be successfully completed with a grade of "C" or better before entering the program. Students must also possess a current CNA certificate.

Need

Enrollment and Completer Projections The annual completion plan would be 15 students every year for the Indian Wells/ Ridgecrest site and 30 students total for the KRV and ESCC sites every other year. Currently, we have up to 40 students each year hoping to have their names drawn in the Vocational Nursing Program lottery at the Cerro Coso main campus at the start of each iteration. ESCC campus also has up to 40 students every other year hoping to get into the Vocational Nursing Program. The KRV program has been proposed as a new site starting Spring 2014. The KRV Program was approved by the BVNPT this last summer (2013).

Place of Program in Curriculum/Similar **Programs**

There are no similar programs like Vocational Nursing in the Cerro Coso Community College service area. This program was revised to be aligned with Bakersfield College and West Hills Community as part of the TAACCCT C6.

'Similar Programs at other colleges in service area

There is one other program in Kern County but not in Cerro Coso Community College service area. This program is located in Bakersfield, California which is approximately 120 miles from Ridgecrest. This would put undue stress upon our students who attend the Cerro Coso's main campus in Ridgecrest. The Cerro Coso Vocational Nursing Program will also be located at Bishop, Mammoth, and Kernville Campuses which is an average of 175 miles from Bakersfield.

Labor Market Information & Analysis (CTE only)

According to the Occupational Report, there is an annual openings estimate of 317 jobs for the year 2013. Currently, there are 45 Job Postings. There is an expected increase of Vocational Nursing jobs between 2012 to 2017 of 609 jobs which is an increase of 11.2%. This does take into account that 44% of the current Vocational Nurses are over the age of 45 and nearing retirement. The Median wage is \$22.20/hr.

Employer Survey (CTE only)

This Program is in response to community needs in both the IWV, ESCC, and KRV areas. An employer survey was not completed. However, the advisory committees and regional trends indicate an increasing need for a Vocational Nursing Program in the Cerro Coso Community College Service area.

Explanation of Employer Relationship (CTE Only)

We have Advisory Groups in both the IWV and ESCC areas that are representative of the industry and employers in the areas. The employers of the Cerro Coso Community College service area provide some expendable equipment. They also provide facilities for Vocational Nursing students to complete their clinical experiences. Some doctor's offices provide subject experts to follow the students and give the students needed guidance. Also, employers in KRV service area have been in contact with the Director of the Vocational Nursing Program asking for a Vocational Nursing Program extension in their area.
