Cyber Security Defense & Operations Bachelor of Science Degree	There needs to be an addition on the government side to add the Cyber Security Defense & Operations BS program to their Human Resources titles for pay scales. They currently use time and experience as a determination for incoming pay. The volume of the current need is driving pay and the government is losing employees to contractors as they move to contractors that will pay them up to \$20,000 more to move their employment. At this time, applicants that have Security+certification, a security clearance some time on the job can demand higher pay rates and jump from one position to another. Their level and depth of understanding of cyber security can be very limited. Employers will welcome a leveling out of this type of competitive environment with a more stable and well equipped cyber workforce. The government and contractors were fully	15 min

		supportive of our program and area willing to support employees in the completion of the program by funding fees and books. They currently do increase pay rates when employees obtain certificates and degrees. The prospect of the BS program will drive wages up once the title is added to the federal government accepted cyber job classifications. The first completers of the BS program will likely be able to obtain \$80,000 as an entry salary due to the shortage and thorough preparation in the field. They are interested in working with the college on internships and placements while students are in the program. Additionally, Jarrod brought up the Administration of Justice and police officers require a Bachelor's degree for promotion. If they do not have a bachelors, in some categories police employees cannot even apply. It is not an option for that field, it is a requirement. Dawn brought up that in the legal field, the move to cloud storage necessitates a workforce that is managing private and protected information in all the legal offices. This BS would fit the requirements would meet the need to protect the data and private information in all professions.
