- **Introductions**
 - Welcome to Chandler Steele and Ashley Thompson
- **New SEAC Team**
 - New Team group created in Microsoft Teams. All information is the same as in the SharePoint and all files are accessible via either access point. All committee members have been granted access to the Team.
- **Vision Aligned Reporting (VAR)**
 - New level of reporting data – activity level – that is associated with the Vision 2030 initiative from the CCCC. Eleven programs are outlined in the shared [memo](#), but this is not a replacement for SSARCC or NOVA for those programs. The structure of this has not been completely determined so will take some time to develop a better understanding. The State is trying to get a better sense of a return on investment by reviewing activity-level data for students. More information will be shared as it becomes available.
- **Part-Time Student Survey**
 - Tyson walked the committee through a Tableau dashboard created by Bryan in IR of the results of the Part-Time Student Survey data. 196 surveys received out of about 2600 students surveyed. The population surveyed is relatively reflective of our populations. Data for Veteran and Foster Youth students is not available through this as those students made up too small of a percentage. Standouts called out by committee: Family/dependents not utilizing CDC services, feedback on telehealth,

student work commitments, desire for evening services, further broken-out morning time block options, food/clothing pantry usage, and whether the students are in or out of the service area.

- **First-Generation CFIT**

- First-Generation student survey went out, 113 responses recorded. CFIT is reviewing the data and using the discussion to determine focus group questions/discussion topics. Focus groups are planned for the week of April 8, with topics ranging from communications, tutoring awareness, faculty support, and student activities/services. In the next SEAC meeting there will be an overview of this data, like the review of the part-time student survey. Mid-April should see a report-out/recommendation from the CFIT.

- **Fraud Update**

- Fraud continues to plague us, now even working around the ID.me implementation. Auto holds will be applied to students below 18 who claim to have graduated from high school. District has an AI net established to auto hold students who opt out of ID.me, but now has been expanded due to continued fraud. A lunch and learn about how syllabi can be updated to define what non-participation looks like or ways faculty can try to tackle this is supported by the committee.
