This is a Certificate of Competency awarded to students who have completed 144 hours ENSL coursework by completing ENSL C801 and ENSL C802. To achieve the English for as a Second Language for the Workforce Certificate of Competency (NC): Upon completion of the required courses with a "P" grade in each course, the student will be awarded an English for as a Second Language for the Workforce Certificate of Competency (NC).

Proposal Start: Fall 2023

Submission Rationale: New Program

Program Justification: A certificate is also required to receive enhanced noncredit funding. "Pursuant to Title 5, Section 55151 colleges may offer a sequence of noncredit courses that culminate in a Certificate of Competency or a certificate in a recognized career field articulated with degree-applicable coursework, completion of an associate degree, or transfer to a baccalaureate institution. For students completing noncredit courses in a prescribed pathway, approved by the Chancellor's Office, that prepares students to take credit coursework including basic skills and ESL, a Certificate of Competency may be awarded. A noncredit Certificate of Competency means a document confirming that a student enrolled in a noncredit educational program of noncredit courses has demonstrated achievement in a set of competencies that prepares students to progress in a career path or to undertake degree applicable or non-degree applicable credit courses. The Certificate of Competency must include the name of the certificate and the date awarded, be identified by a TOP Code number and program discipline, and list the relevant competencies achieved by the student" (Program and Course Approval Handbook, p. 120).

Cerro Coso Community College does not currently offer English as a Second Language (ENSL) coursework. English as a Second Language for the Workforce will help develop skills for students looking to enter or improve their position in the workforce. The English as a Second Language for the Workforce Certificate of Competency (NC) will provide both an accessible goal and evidence of learning for students. The program aligns with title 5, section 55151 by preparing students for a career path.

Master Planning – Describe how the Program/Certificate aligns with the mission, curriculum, and master planning of the College and higher education in California?

The Cerro Coso Community College mission states that, "The mission of Cerro Coso Community College is to improve the life of every student it serves by prioritizing equity and supporting attainment of educational goals. Through innovative delivery methods, Cerro Coso Community College provides transfer preparation, workforce education, degree pathways, and comprehensive student support services to develop ethical and effective citizenry throughout our vast rural and online communities." This program helps students attain a tangible educational certificate that connects them directly to workforce skills, specifically in workforce communication and workforce conversation. It will help students communicate, connect, and engage more effectively throughout the rural and highly populated communities of Kern County.

The Cerro Coso Community College vision states, "Cerro Coso Community College will be the first choice in higher education and workforce training for the Eastern Sierra region." This program will help students attain key workforce training and skills so that they can enter, improve, and/or boost employment opportunities that are essential to the success of a community.

In addition, Cerro Coso Community College is an institution that meets the requirements and has been designated as a Hispanic Serving Institution (HSI). This certificate creates an institutional instructional mechanism that allows for expansion of educational opportunities and enhanced academic offerings for Hispanic students.

Van Noy, M., Jacobs, J., Korey, S., Bailey, T., & Hughes, K. L. (2008) state that "Noncredit workforce education can play an important role in responding to local labor market demands by addressing employers' workforce needs and students' needs for immediate skills." These immediate skills include the ability to communicate (both verbally and in written format) along with and converse clearly in the working environment. Workplace English language skills is the focus and will be developed with the completion of English as a Second Language for the Workforce Certificate of Competency.

Cerro Coso Community College will recruit adjunct faculty that meet the below minimum qualifications as listed in the Minimum Qualifications for Faculty and Administrators in California Community Colleges (17th edition – June 2022).

Bachelor's degree in teaching English as a second language, or teaching English to speakers of other languages

Bachelor's degree in education, English, linguistics, applied linguistics, any foreign language, composition, bilingual/bicultural studies, reading, or speech; and a certificate in teaching English as a second language, which may be completed concurrently during the first year of employment as a noncredit instructor

OR

Bachelor's degree with any of the majors specified in subparagraph (2) above; and one year of experience teaching English as a second language in an accredited institution; and a certificate in teaching English as a second language, which may be completed concurrently during the first two years of employment as a noncredit instructor

OR

Possession of a full-time, clear California Designated Subjects Adult Education Teaching Credential authorizing instruction in English as a second language.

The Department does not anticipate the need for new/remodeled facilities for this Program.

The two non-credit classes leading to this certificate have only recently been approved by college institutional processes. The plan is to pilot the courses in fall 2023 in the community of Tehachapi first and then offer them in other college service areas. Annual completion projections will require research and time so that it can be accurately determined.

English as a Second Language for the Workforce Certificate of Competency (NC) will be housed in the English & Foreign Language department.

To the best of our knowledge, no other colleges within our service area(s) offer English as a Second Language (ENSL) courses or a comparable certificate. Bakersfield College offers a wide variety of ENSL coursework, but their campus locations are at least one to five hours away (based on Cerro Coso Community College's service area location). Most Cerro Coso Community College's service area communities are classified as rural. The English as a Second Language for the Workforce Certificate of Competency (NC) will provide access for students living in rural locations with limited higher education opportunities. Local K-12 school districts do offer a variety of levels of adult education ENSL courses, but during the creation of English as a Second Language for the Workforce Certificate of Competency (NC), our college made sure to be cognizant of this partner and created a program to complement the adult education ENSL efforts by focusing on workforce development.
