Quizzes on artists, art genres and periods, how culture is expressed through art, artistic content vs. form, and a multitude of other art topics. Library research, written essays, museum and gallery visits, attendance at cultural events.

Example: Students are required to visit a virtual gallery in order to perform research on a specific artist, art movement, or cultural phenomenon to more thoroughly understand the relevant contribution to the field of art.

Tests	Written assignments, which may include journal entries, quizzes, essays, vocabulary lists, exams, or reports. Example: Students complete multiple choice quizzes to assess knowledge of presented lecture or demonstration content.
Project	Projects. Example: Students create a drawing that results in an accurate rendering of an extant image, using various methods to defeat "symbolic" perception. Methods could include: placing the original image upside down, revealing small portions of the original image, and analyzing specific angles or forms within the image.
