- 3. M&O and other services, how are SLOs and PLOs being reviewed? Are they reporting in Curricunet?
- 4. Some AUPs included information related to assessment in other portions of the document. Need to thoroughly read through each AUP in order to fully capture all themes.
- 5. Public Information CCSSE is only on ground, how are they assessing online?
