A spreadsheet to track SLO assessments is needed because the current tool has deficits and does not allow for accurate or meaningful tracking and reporting.  Move SLO/PLO assessment towards the 95% mark.  Corey has set the following expectations:  ALL departments, without exception, will be at 85% by March 1, 2016.  ALL departments, without exception, will be at 90% by next October 1, 2016  Specific strategies and support need to be developed for disaggregating outcomes for subpopulations of students important to its mission.  Disaggregation occurs in PR, but not directly related to specific student learning outcomes. The college needs to move to a management system (ie SLO Cloud) that allows for disaggregation at the SLO level.  Dialogue about student learning is ongoing, pervasive, and robust. 		<ul> <li>No goals were identified in Spring 2015.</li> <li>*Programs with less than 85% of their courses assessed are not eligible to complete Program Review. This language will be added to the Program Review template and will be communicated to Department Chairs during the Fall 2015 Program Review training. The target will move, to somewhere in the 95% (to allow for new courses), over the next few years.</li> </ul>

		*Additional Work: (keeping these items in our sights)  ILO task force is working on draft Institutional Learning Outcomes. Mapping will need to occur from ILO -> GELO -> PLO -> SLO  Liberal Arts redefine Learning Outcomes and mapping. Develop an effective method to assess.  Moving towards best practice – collaborative assessment of non-objective assessments.  Use the SLO moodle, create a block for each department. Assessment tools, data and department minutes related to learning outcome assessment can be uploaded. This allows all faculty to easily be able to access the most up to date Assessment tool for their course. Goal #2 "Dialogue about student learning is ongoing, pervasive, and robust." Goal #5 "Student learning improvement is a visible priority in all practices and structures across the college."  Development of Learning Assessment website.  Related discussion: SLO assessment is viewed as part of the faculty member's load and responsibility. Full time should be doing the majority of the work, however, if there is a case where an adjunct is asked to create assessments, additional compensation might be considered. This would be very limited.  SLO Committee members are encouraged to offer support and be a resource to faculty in their review areas, however, reminded that it is not their responsibility to DO the work.

		move to a new system.  Move forward with the SLO Moodle, create a database with items to prompt assessment entry. Ideally this will be up and running in time for the October 1 assessment deadline, avoiding entering more assessments into CurricUNET. Suggest database for each department for SLO assessments, one for PLO assessments, and an area to upload department minutes when related to assessment. Vivian will contact Rebecca and Justin to get that started.  An example of an assessment might be helpful when faculty are filling in the fields. What is meant by target performance, assessment plan, etc.  To address the current back log in CurricUNET, the committee agreed Vivian will review each assessment, skipping the review process (since it's not working). She will contact the appropriate faculty member, Chair, and administrator if an assessment needs work and remains unchanged.  Corey expects to hear from Betty in the near future regarding SLO alternatives and where we are in screening potential systems. The State Chancellor's office also said they were meeting with Gov'net and may be ending association depending on that outcome. We've not heard anything further.
