- **Banner 9 upgrade** – A banner 9 training plan is being developed by the banner steering committee, this plan will include both banner 9 and ongoing and new employee training.
- **Network Upgrade** – At the October board meeting the board approved the new Digital 395 contract. This new contract will upgrade our network back to the district office from 100mb to 300mb. At KRV we are working with media com to purchase a 100mb service to off load all internet traffic to, this will free up the 10mb stacked T1's for internal traffic such as email, ITV, and banner.
- **Future Network Upgrade** – The state community college system is purchasing 10gb connections for all community colleges. This will include the sites at each college. The time line for this is 18 – 24 months before we have it fully implemented but it is coming and will have a big impact on our network.
- **Hardware Replacement Plan** – The current 5 year HRP plan has expired. We need to put together a new one. The department is recommending a 7 year replacement plan. We have 684 computers and laptops to replace, 486 lab and classroom instructor stations, 143 staff and faculty desktops, and 55 staff and faculty laptops. I have identified the computers that need to be replaced for the next year as part of my unit plan. In the next fiscal we are replacing 111 ESCC lab and instructor stations, 12 IWV instructor stations, 5 KRV instructor stations, 10 library laptops, and 10 staff and faculty laptops. For a total cost of just over \$100K
