Per the Cerro Coso Community College Catalog, students have the right to file for Academic Renewal.

Academic Renewal Policy

According to KCCD Board Policy, a maximum of 20 units of substandard grades ("D" and "F" and "NP" grades) previously recorded may be alleviated and disregarded for the purpose of determining a satisfactory grade point average. This may be accomplished under the following conditions:

1. Two (2) years must have elapsed since the substandard course work to be disregarded was completed.

2. The student must have successfully completed with a grade point average of 2.5 or higher at least 18 units of work at any regionally accredited institution **subsequent to the last substandard grade received**.

3. The student must complete a petition for Academic Renewal with the assistance of a Cerro Coso Community College counselor for submittal to the Academic Petitions Committee (APC). The petition must certify in writing all of the following:

a. That the past course work he/she wishes to have disregarded is substandard and not representative of present scholastic ability and level of performance.

b. That current coursework meets established academic standards including or exceeding the standards set above, and is substantiated by current course history or official transcripts (must be attached).

If the substandard course work has been taken at another college, the student should make every effort to determine whether that college has an academic renewal ("forgiveness") policy covering substandard course work. If the student can substantiate in writing that no such policy exists (an email from a counselor or administrator at the previous institution), official transcripts and a petition for academic renewal (the cumulative GPA, calculated using the previous institution's transcript and the current academic history at Cerro Coso, may be adjusted by "forgiving 20 units of substandard work" in the final GPA calculation ONLY. No adjustment is ever made to the previous records.

The student's academic record will clearly indicate that some course work and a specified number of credits have been disregarded ("forgiven") for purposes of the degree program. However, students should be aware that all course work is subject to reevaluation by each subsequent college attended (Cerro Coso Community College 2010-2012, p 149-150).

The process by which this occurs will be that students' desiring to petition for renewal should:

- 1. make an appointment with their counselor and complete the form
- 2. provide adequate documentation (counselors may provide printed or electronic copies of Course History and/or Official Transcripts) of current academic success.

The counselor should then print and attach the required Banner documentation for review by the committee. Counselors can advise their students of the committee meeting times. Petitions must be submitted two weeks prior to the meeting date to be considered during that session. All petitions will be considered at the first available session based on submission date.

The chair shall provide the committee with copies of each petition and supporting documentation by no less than 5 working days prior to the committee meeting.

The committee shall meet the last week of September and the last week of November for the Fall semester and the last week of February and the last week of April for the Spring semester. Once the committee has convened and acted upon the petitions copies will be submitted to Admissions & Records for processing (may take 2 – 3 weeks) and returned to the counselor who will notify the student of the outcome.

Students have the right to appeal the decision of the committee by submitting their appeal in writing to the Vice-President of Student Services.
